The Hear Bank – Kelsie Martin

- Goals: provide children who are deaf and hard of hearing access to amplification.
- Loans of devices are for six months.
- The Hear Bank services the entire state of Minnesota.

Local Public Health Assessment – Renae Allen

- EHDI Screenings: offer the Follow Along Program, communication with parents, interpreters, and clinic.
- EHDI Confirmed Hearing Loss: outreach, refer, home visit, assess five areas.
 - Five areas: income, communication and community resources, caretaking / parenting, growth & development, health care supervision.
- Potential for second assessment.

cCMV Update from MDH – Kirsten Coverstone

- Screening and follow-up are going well.
- The occurrences are lower than expected, but the data is still new.
- In the majority of cases, the babies have been asymptomatic.
- All with confirmed cCMV have been referred to Local Public Health for follow-up nursing assessment.
- There are a few hiccups with getting the correct audiology appointment type scheduled but working through those.
- Many questions on the vestibular component of guidelines.

Minnesota State Academies for the Deaf and Blind – Terry Wilding

- Whole-child development.
- Accessible curriculum.
- Additional learning opportunities: independent living skills, extracurricular activities, college level classes, electives, extended school year, and the Pathways to Life Program.
